### **IOM Forum Agreement and Medical Disclaimer**

**Updated July 14, 2011**

IOM Forum is a World Wide Web-based health community, information and communication service provided by ORIMtec Quantum Neuromonitoring Corporation (“ORIMtec”). As used in this IOM Forum Agreement and Medical Disclaimer (“Agreement”) “We”, “Us”, or “Our” refers to ORIMtec and “You” or “User(s)” refers to users of IOM Forum. Together, all are referred to as (“Parties”).

The terms and conditions of this Agreement may change periodically. Any modifications will take effect immediately by posting on the ORIMtec website. **WARNING:** Online usage of IOM FORUM is monitored by ORIMtec to prevent violations of this Agreement by Users.

**PLEASE READ THE TERMS AND CONDITIONS OF THIS AGREEMENT CAREFULLY BEFORE ACCESSING OR USING IOM FORUM. BY ACCESSING OR USING IOM FORUM, USER AGREES TO THE TERMS AND CONDITIONS OF THIS AGREEMENT. IF USER IS NOT WILLING TO BE BOUND BY THIS AGREEMENT, USER MAY NOT ACCESS OR USE IOM FORUM.**

#### **A. User Obligations and Ownership**

User agrees that User will not, during or after the term of this Agreement, take any action which may lead to the unauthorized dissemination, reproduction or use of IOM Forum or its contents. User agrees not to copy, duplicate, swap, rent, sublicense, transfer, sell, upload, download, display or offer IOM Forum or its contents to any person or entity in any medium or nature whatsoever.

User shall have no right, interest, or license in IOM Forum other than the rights expressly granted in this Agreement. All rights, title, and interest in IOM Forum including, but not limited to, all copyrights, are the exclusive property of ORIMtec.

#### **B. Agreement Terms**

Subject to User's compliance with the terms and conditions of this Agreement, ORIMtec grants to User a non-exclusive, non-transferable, non-sub-licensable limited license to use IOM Forum as permitted in this Agreement. User may not download, upload, publish, distribute, transmit or sell any materials retrieved through the use of IOM Forum as permitted in this Agreement.

This Agreement will terminate immediately: (a) upon termination or cancellation of User's membership, registration, or access to IOM Forum; (b) upon User's breach of or failure to comply with this Agreement in whole or in part; or (c) in the event ORIMtec elects, in its sole discretion, to cease offering access to IOM Forum online. Termination of this Agreement by

ORIMtec shall not give rise to the right for User to recover any damages.

The material on IOM Forum is for the private, non-commercial use of Users only. Any other use is strictly prohibited. Users agree they will not copy, publish, or in any way make available publicly any post, comment, news, pictures, interviews, features, or any other information from IOM Forum or ORIMtec. Additionally, reuse of copyrighted, Confidential and Medical Information, as defined below, will be prosecuted to the fullest extent of the law.

User agrees not to use IOM Forum for illegal purposes or for the transmission of material that is unlawful, harassing, libelous or defamatory, hateful, obscene, profane, abusive, invasive of another's privacy, abusive, threatening, obscene, an infringement of copyrighted material or intellectual property of another ("Prohibited Material") or in violation of International or United States Federal law. This includes User agreeing to refrain from posting, disclosing or making available to any third party or other User any Prohibited Material, Confidential and Medical Information, or illegal material.

User agrees not to post any copyrighted material unless User owns the copyright or User has written consent from the owner of the copyrighted material. Spam, flooding, advertisements, chain letters, pyramid schemes, and solicitations are also forbidden on IOM Forum.

User has the ability, upon registration, to choose a username. We advise that User keep the name appropriate. With this user account User is about to register, User agrees to never give User's password out to another person except an administrator, for User's protection and for validity reasons. User also agrees to NEVER use another person's account for any reason. We also HIGHLY recommend User use a complex and unique password for your account, to prevent account theft.

After User registers and logs in to IOM Forum, User will be able to fill out a detailed profile. It is User's responsibility to present clean and accurate information. Any information the forum owner or staff determines to be inaccurate or vulgar in nature will be removed, with or without prior notice. Appropriate sanctions may be applicable.

Please note that with each post, User's IP address is recorded, in the event that User needs to be banned from this forum or your ISP contacted. This will only happen in the event of a violation of this agreement.

Also note that the software places a cookie, a text file containing bits of information (such as your username and password), in User's browser's cache. This is ONLY used to keep you logged in/out. The software does not collect or send any other form of information to User's computer.

### **C. Confidential and Medical Information**

User shall not disclose or cause to be disclosed on IOM Forum or from IOM Forum to any third party any Confidential and Medical Information, as defined below.

User shall not disclose any information which is protected under federal and state law relating to medical or patient information or any information which may identify a patient, individual or User as a patient ("Confidential and Medical Information"). This shall include, but is not limited to, information of a patient, User, and/or any other individual that contains: **names; any information relating to past, present or future physical or mental health condition; any provision of health care; any past, present or future payment information for the provision of health care; geographical areas; any elements of dates including birth dates, admissions dates, discharge dates, and any or all ages over 89; telephone numbers; facsimile numbers; electronic mail addresses; social security numbers; medical record numbers; health plan beneficiary numbers; account numbers; certificate or license numbers; vehicle identifiers and serial numbers, including license plate numbers; devise identifiers and serial numbers; web universal resource locator (URL); internet protocol (IP) address number; biometric identifiers, including finger or voice prints; full face photographic images and any comparable images; any unique identifying number, characteristic or code; and any other information for which there is a reasonable basis to believe could be used to identify an individual, patient, and/or User.**

#### **D. Warranties, Disclaimer, and Limitation of Liability**

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IOM FORUM AND THE INFORMATION CONTAINED ON IT IS PROVIDED "AS IS" AND WITH ALL FAULTS, WITHOUT WARRANTY OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, WARRANTIES OF PERFORMANCE, MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR NON-INFRINGEMENT.

ORIMTEC SHALL NOT BE LIABLE TO USER FOR ANY CLAIM RELATING IN ANY WAY TO THE USE OR INABILITY TO USE IOM FORUM, INCLUDING WITHOUT LIMITATION CLAIMS ARISING FROM THE INACCURACY OR INCOMPLETENESS OF THE INFORMATION CONTAINED ON IOM FORUM, THE USER'S INABILITY TO ACCESS IOM FORUM OR PERFORM SEARCHES (EVEN IF USER'S ACCESS TO IOM FORUM HAS BEEN TERMINATED WITHOUT NOTICE BY ORIMTEC), OR INCOMPATIBILITY OF IOM FORUM WITH ANY SOFTWARE, HARDWARE, OR OTHER EQUIPMENT. ORIMTEC SHALL NOT BE LIABLE FOR ANY LOST PROFITS OR OTHER CONSEQUENTIAL, EXEMPLARY, INDIRECT, GENERAL OR SPECIAL DAMAGES RELATING TO USER'S RIGHTS IN THIS AGREEMENT, OR USE OF, OR INABILITY TO USE, IOM FORUM IN ANY WAY (INCLUDING INTERRUPTION OF BUSINESS, DAMAGE TO SOFTWARE OR HARDWARE, OR LOSS OF USE, DATA, OR OTHER ECONOMIC ADVANTAGE), REGARDLESS OF THE THEORY OF LIABILITY, WHETHER FOR BREACH OF THIS AGREEMENT, INCLUDING BREACH OF WARRANTY, OR IN TORT OR OTHERWISE.

No waiver of any provision shall be valid unless in writing and signed by ORIMtec. Nothing in this Agreement or any other agreement between the User and ORIMtec is intended to create a partnership, franchise, joint venture, agency, employment, or any other relationship.

This Agreement and all related disputes shall be governed by the laws of the State of California and venue for any litigation arising out of this Agreement and/or IOM Forum content shall take place in Sacramento County, California. Should any provision of this Agreement be found to be void, invalid, or unenforceable by a court of competent jurisdiction, the remaining provisions shall remain in full force and effect.

Neither this Agreement, nor any portion thereof, may be assigned, sublicensed, loaned, leased, distributed or transferred by User. Any such assignment or transfer in violation of this Agreement shall be null and void. ORIMtec may assign and/or delegate the rights and/or obligations of this Agreement, in whole or in part, in its sole discretion. #### **F. Indemnity**

User shall hold harmless, defend, and indemnify ORIMtec from any and all claims, liabilities, damages, expenses, costs, penalties or fines (including reasonable attorneys' and expert fees) arising from (a) User's use of IOM Forum; and/or (b) User's failure to comply with the terms of this Agreement.
